03.06-09-126. **TMC BOARD TO DISCUSS AND ACT ON THE FOLLOWING:**

- a. Discussion and approval to postpone the July 11, 2009 Bi-Monthly Meeting due to the numerous calendars of activities and vacation schedule of Board Members and Staff and any matter incident thereto and authorizing the CEO to execute all relevant documents.

Ms. Capello explained that due to conferences, travel and vacation schedules it was recommended by the Executive Committee to cancel the July meeting and meet on an as needed basis with Special called meetings.

It was moved by Ms. Blanca Munoz and seconded by Judge Juan Velasquez to approve and postpone the meeting of July 11, 2009.

Motion was approved unanimously.

- b. Discussion and approval of the submission of the following funding applications to the United States Department of Human Services, Office of Head Start and authorizing the Chief Executive Officer to execute all relevant documents and any matters incident thereto:
 1. Migrant Seasonal Head Start Expansion
 2. Head Start Expansion
 3. Early Head Start Expansion

4. Migrant Seasonal Head Start One-Time
5. Head Start – One-Time
6. Early Head Start-One-Time

Ms. Capello explained the One-time applications for Migrant Seasonal Head Start, Head Start/Early Head Start; and the Head Start Expansion. Ms. Capello explained these are the standard applications that are submitted to the Office of Head Start on an annual basis. The total funding would be about \$6 million with the exception of the start – up one-time.

It was moved by Ms. Blanca Munoz and seconded by Mr. Francisco Flores to approve the submission of the applications as listed above.

Motion was approved unanimously.

- c. Discussion and possible action to amend TMC's Policy Council By-Laws.

Board members recommended tabling the item as they did not have time to review the policies. It was suggested by Mr. Vidal Cantu and seconded by Judge Juan Velasquez to have our Law firm review item **03. 06-09-126 c** before final approval of the board. The item was tabled.

Motion was approved unanimously.

- d. Discussion and possible action to amend TMC's Standards of Conduct.
- e. Discussion and possible action to amend TMC's Dress Code Policy.

It was recommended by the Board to table items 03.06.09.126 d and e for further review by the board.

It was moved by Mr. Miguel Lopez and seconded by Reverend Chester Phyffer to table items **03.06-09-126 d and e** as suggested by the Board.

Motion was approved unanimously.

- f. Discussion and possible action to amend TMC's Policies on Criminal Background Checks and Felony Convictions.

Ms. Capello explained to the Board the need to implement the Criminal Background and Felony Convictions Check in order to determine the suitability of a prospective employee or present employee due to the sensitivity and safety of the children. Judge Velasquez recommended that our legal law firm review/research in order to define the correct language to the policy and that the policy be in conformity of all eight states. TMC is committed to protect the best interest of its children and employees; and is strongly recommending the implementation of this policy.

It was moved by Mr. Vidal Cantu and seconded by Judge Juan Velasquez to approve as per recommendations of Ms. Mary Capello and have legal finalize the final document.

Motion was approved unanimously.

- g. Discussion and Possible action to approve the submittal of an application for funding to the U.S. Department of Education in partnership with Intercultural Development Research Association (IDRA) for the "The Early Reading First Program" for fiscal year 2009 to provide funding and

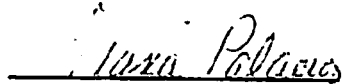
support to turn preschool programs into preschool centers of educational excellence by improving instruction and classroom environments through scientific research-based practices in spoken and written language, vocabulary, cognition, and early reading and authorization for Chief Executive Office to execute all relevant documents and any matters incident thereto.

It was moved by Mr. Miguel Lopez and seconded by Ms. Grace Camargo to approve the submittal of the application for the "The Early Reading First Program" to the U.S. Department of Education.

Motion was approved unanimously.
